



2023 Access Plan



TAC §11.1607(h):

An HMO is required to provide an adequate network for its entire service area. All covered services must be accessible and available so that travel distances from any point in its service area to a point of service are no

(1) 30 miles for primary care and general hospital care; and

(2) 75 miles for specialty care, specialty hospitals, and single healthcare service plan physicians or providers.

TAC §11.1607(j):

If any covered health care service or a participating physician and provider is not available to an enrollee within the mileage radii specified in subsection (h)(1) and (2) of this section because physicians and providers are not located within such mileage radii, or if the HMO is unable to obtain contracts after good faith attempts, or physicians and providers meeting the minimum quality of care and credentialing requirements of the HMO are not located within the mileage radii, the HMO shall submit an access plan to the department for approval, at least 30 days before implementation in accordance with the filing requirements in §11.301 of this title (relating to Filing Requirements).

The access plan shall include the following:

(1) **the geographic area identified by county, city, ZIP code, mileage, or other identifying data** in which services *and/or* physicians and providers are not available;

(2) for each geographic area identified as not having covered health care services and/or physicians or providers available, **the reason or reasons that covered health care services and/or physicians and providers cannot be made available;**

(3) **a map, with key and scale, which identifies the areas in which such covered health care services and/or physicians and providers are not available;**

(4) **the HMO's plan for making covered health care services and/or physicians and providers available** to enrollees in each geographic area identified;

(5) **the names and addresses of the participating physicians and providers and a listing of the covered health care services** to be provided through the HMO delivery network to meet the medical needs of the enrollees covered under the HMO's plan required under paragraph (4) of this subsection;

(6) **the names and address of other physicians and providers and a listing of the specialties for any other health care services or physicians and providers to be made available in the geographic area** in addition to those physicians and providers participating in the HMO delivery network listed under paragraph (5) of this

(7) **the procedures to be followed by the HMO** to assure that primary care physicians, general hospitals, specialists, special hospitals, psychiatric hospitals, diagnostic and therapeutic services, or single or limited health care service providers and all other mandated health care services are made available and accessible to enrollees in the geographic areas identified as being areas in which such covered health care services and/or physicians and providers are not available and accessible, and any plans of the HMO for attempting to develop an HMO delivery network through which covered health care services are available and accessible to enrollees in these geographic areas in the future; and

(8) **Any other information which is necessary to assess the HMO's plan.**

ACCESS PLAN

Per §11.1607(j) (7), the following is a description of the processes and procedures followed by Baylor Scott & White Health Plan (BSWHP) to assure that services are made available and accessible to enrollees for all specialties and in all geographic areas which are identified in the remainder of the access plan.; it is entered in this section to avoid repetition in each section below:

Baylor Scott & White Health Plan (BSWHP) has active policies and procedures in place that enable members to utilize authorized services as in-network, in all counties and for all specialties/services, where the network lacks a sufficient number of providers to meet the needs of enrollees. Baylor Scott & White Health Plan (BSWHP) then negotiates a Letter of Agreement with the out-of-network provider to ensure the member receives in-network benefit coverage. Covered member is not balance billed and/or penalized by Baylor Scott & White Health Plan (BSWHP) for any specialty/service that is identified in an area that does not have a required provider specialty for the covered member. Covered member will not be penalized or denied care for other benefits due to network inadequacy or lack of freedom of choice.

The information below describes the counties and specialties where Baylor Scott & White Health Plan (BSWHP) does not have an adequate provider network per the requirements set forth in TAC §11.1607. A plan to enable enrollees to obtain in-network benefits is provided in each section. Baylor Scott & White Health Plan (BSWHP) has active policies and procedures in place that enable members to utilize authorized services as in-network in all counties and for all specialties and services where the network is inadequate. Baylor Scott & White Health Plan (BSWHP) negotiates a Letter of Agreement with the out-of-network provider to ensure the member receives in-network benefit coverage. Covered member is not balance billed and/or penalized by Baylor Scott & White Health Plan (BSWHP) for any specialty or service that is identified in an area that does not have a required provider specialty for the covered member. Covered member will not be penalized or denied care for other benefits due to

In the event a Member is unable to get specialized services within the contracted network; our contracting team will immediately research and identify a Provider to administer the service. Once a Provider is identified, we will execute a Single Case Agreement with that Provider and begin the contracting process.

Baylor Scott & White Health Plan (BSWHP) leadership continually evaluates the adequacy of the provider network through various means such as the Network Issues Committee that meets once per month, monitoring concerns and access issues from Members and other providers, and business expansion strategies. Baylor Scott & White Health Plan (BSWHP) negotiates single-case agreements and letters of agreement to assist with gaps in coverage in areas where there is a lack of providers, especially in rural areas. Baylor Scott & White Health Plan (BSWHP) includes the following hold-harmless language in its single case agreements and letters of agreement, to ensure that members will not be balance billed for services by out-of-network providers when the provider network is

“Provider hereby agrees that in no event, including, but not limited to non-payment by Baylor Scott & White Health Plan (BSWHP) , insolvency, or breach of this Agreement, shall Provider charge, collect a dHMOsit from, seek compensation, remuneration or reimbursement from, or have any recourse against Member or any person or persons acting on her behalf for Services provided pursuant to this Agreement.”

Additional Information

1. The provider list (provider directory and/or online directory) includes individual provider(s) listed many times at several different addresses; for availability and accessibility of care within the service area, an individual provider that the provider listed numerous times, can adequately serve the enrollee population when they have multiple practice addresses because many of Baylor Scott & White Health Plan (BSWHP) contracted group’s employee physicians that rotate between practice facilities. For example, Provider A works at location 1 Monday thru Wednesday and then Provider 2 works at location 1 Thursday thru Sunday. For hospital based provider groups, Baylor Scott & White Health Plan (BSWHP) is contracted with groups that consist of 30 or more providers that rotate between 5 or more hospitals in order to ensure each hospital is covered 24 hours a day, 7 days a week.

2. There are repeated providers on our provider list that are practicing within a group/company that has multiple locations (i.e. large clusters of providers listed at the same addresses). The contracts for these sites are at the group level but some are individually contracted providers. Contracting duties are not delegated. There are times that Baylor Scott & White Health Plan (BSWHP) delegates credentialing if the group has at least 100 providers and the group does the credentialing of their own providers. A pre-delegation assessment is completed to ensure the group follows the same regulatory standards as Baylor Scott & White Health Plan (BSWHP) . All contracts are evergreen and auto renew.

4a. An estimate of total claims cost savings per year the insurer anticipates will result from using a local market access plan instead of contracting with providers located within the service area, and its impact on premium; Baylor Scott & White Health Plan (BSWHP) does not use a local access plan in lieu of contracting with providers within the service area. The access plan is used in situations where there are no providers available to contract, a provider is in the process of being credentialed, or when services are to be provided by a contracted facility. Given that the access plan is not used in place of contracting there are no savings to the health plan and therefore, no impact on premium.
