### Important note:

Baylor Scott & White Health Plan (BSWHP), and all wholly owned subsidiaries including FirstCare Health Plans (FC), monitors policy changes from the Centers for Medicare & Medicaid Services (CMS), the federal government and the Texas State Legislature pertaining to the Coronavirus (COVID-19). Please check this site frequently as any new guidance or information will be updated as it becomes available.

**SERVICE:** COVID-19 Telehealth and Telemedicine

**PRIOR AUTHORIZATION:** Not applicable.

**POLICY:** Effective March 6, 2020, BSWHP expanded telehealth and telemedicine services and reimbursement for ALL contracted providers across ALL lines of business including Commercial and Government Programs (i.e. Medicare Advantage, DSNP, Medicaid STAR and CHIP).

### Providers Impacted:

- All BSWHP contracted medical, behavioral, and mental health providers – All eligible in-network medical providers who have the ability and desire to connect with their patients through synchronous virtual care (live video-conferencing) or asynchronous care (non-video care e.g., online) to perform Telemedicine (Physician Delivered) or Telehealth (NON-Physician delivered) are permitted to do so.
  - Exclusions – Public-facing platforms (Tik Tok, Twitch, Facebook Live, and similar video communication applications.)
  - Visit [HHS.gov](https://www.hhs.gov) for more information on allowed/excluded platforms

### Member cost-sharing:

- **Treatment cost-sharing waiver ended July 1, 2021 for all lines of business EXCEPT for Medicare lines.**  
**Treatment cost-sharing waiver will end for Medicare lines June 1, 2022**  
**NOTE** that cost-share **DOES** apply to treatment with the drug Remdesivir.
- **Vaccine** cost-sharing waiver continues for ALL lines of business (Applies to ALL Food and Drug Administration (FDA) provided Emergency Use Authorization (EUA) COVID vaccines, including boosters.)
- **Monoclonal antibody therapy** cost-sharing waiver continues for ALL lines of business when used as authorized or approved by the FDA
- **Testing** (Prescribed/non-OTC)
  - ✓ No member cost-share for ALL lines of business
  - ✓ No prior authorization requirements
  - ✓ Applicable for INN and OON providers

### Member Eligibility:

- This policy change applies to Members whose benefit plans cover telehealth and telemedicine services. Please note that the member cost-sharing waiver ended July 1, 2021 for all lines of business EXCEPT for Medicare lines. **Medicare cost-sharing waiver will end June 1, 2022**

### Reimbursement and Correct Coding:

- **BSWHP will compensate providers** at 100% of the allowable amount as specified in the provider's agreement or fee schedule for telehealth or telemedicine services. **Beginning July 1, 2021, the member cost-sharing waiver ended for all lines of business EXCEPT for Medicare lines. Medicare cost-sharing waiver will end June 1, 2022**
- Medical, Behavioral, and Mental Health Providers: For the time period specified above, services listed in the ([Codes below](#)) are covered and reimbursable under this policy.
- **Documentation requirements** for a telehealth/ telemedicine services are the same as those required for any face-to-face encounter, with the addition of the following:
  - A statement that the service was provided using telemedicine consultation
- **Correct Coding:**
  - **Commercial Plans** (including Self Insured Groups and High Deductible Plans)
    - **Effective dates of service (DOS) March 6, 2020** forward, until further notification by the Health Plan as deemed by Regulatory Entities.
    - **Any originating site requirements** that may apply are waived for telehealth and telemedicine services provided via a real-time audio and/or video communication system and are reimbursable.
    - **Place of Service** for telehealth / telemedicine services: **"10"** - Telehealth Provided in Patient's Home, **"02"** Telehealth (per CPT guidelines), OR the place of Service (POS) equal to what it would have been had the service been furnished in-person (per CMS guidelines).
    - **BSWHP will reimburse telehealth and telemedicine services**, which are on the list of CMS-approved telehealth services and/or published by the AMA in Appendix P of 2021 CPT®, and appended with modifier "95", modifier "GT" for Critical Access Hospital Method II providers, modifier "GQ" for services furnished as part of a federal telemedicine demonstration project in Alaska and Hawaii using asynchronous (store and forward) technology, and modifier "G0" for services furnished for diagnosis and treatment of an acute stroke
    - **Face-to-Face visits** will have a Member share of cost assessed, and the Member is responsible to pay the provider their share of cost.

  - **Medicaid STAR & CHIP Plans**
    - **As directed by HHSC.**
    - **Telephonic (audio-only) medical (physician-delivered) evaluation and management services are eligible for reimbursement for dates of services from March 20, 2020.**

- **Place of Service** for telephonic/telehealth/telemedicine services: “10” - Telehealth Provided in Patient's Home OR “02” - Telehealth for most provider types; “50” for FQHCs, and “72” for RHCs.
- **BSWHP will reimburse telephonic, telehealth, and telemedicine services**, which are recognized by HHSC and appended with modifier 95.
- **Refer to [COVID-19 Billing Reference](#) below for specific ICD-10 Diagnosis coding requirement related to Face-to-Face COVID-19 visits (Non-telephonic/telehealth/telemedicine delivery).**
- Telephonic evaluation and management services are not to be billed if clinical decision-making dictates a need to see the patient for an in-person or telemedicine (video) office visit within 24 hours or at the next available appointment. In those circumstances, the telephone service shall be considered a part of the subsequent office visit. If the telephone call follows an office visit performed and reported within the past seven calendar days for the same diagnosis, then the telephone services are considered part of the previous office visit and are not separately billed.

- **Medicare Advantage including Dual Eligible Special Needs Plans**
  - **Effective dates of service (DOS) March 6, 2020** forward, until further notification by the Health Plan as deemed by Regulatory Entities.
  - **Any originating site requirements** that may apply under Original Medicare are waived for telehealth and telemedicine services provided via a real-time audio and/or video communication system and are reimbursable.
  - **Place of Service** for telehealth / telemedicine services: “10” - Telehealth Provided in Patient's Home (effective 4/1/2022), OR Place of Service (POS) equal to what it would have been had the service been furnished in-person,
  - **BSWHP will reimburse telehealth and telemedicine services**, which are recognized by CMS and appended with modifier “95”, modifier “GT” for Critical Access Hospital Method II providers, modifier “GQ” for services furnished as part of a federal telemedicine demonstration project in Alaska and Hawaii using asynchronous (store and forward) technology, and modifier “G0” for services furnished for diagnosis and treatment of an acute stroke.   - **Face-to-Face visits** will have a Member share of cost assessed, and the Member is responsible to pay the provider their share of cost.
  - **Refer to [COVID-19 Billing Reference](#) below for specific ICD-10 Diagnosis coding requirement related to Face-to-Face COVID-19 visits (Non-telehealth / telemedicine delivery).**

## Codes

### Important Note

### Procedure Codes Approved for Telemedicine Services

All telehealth services must meet the following criteria:

- Appropriate use of code in accordance to Regulator's Direction and AMA Coding Guidelines for Telemedicine / Telehealth
- Appropriate Modifier ("95", "G0", "GQ" or "GT") must be used according to Regulator's Direction and AMA Coding Guidelines for Telemedicine / Telehealth

### COVID-19 Laboratory Diagnostic Testing

- BSWHP will pay 100% of the allowed amount for medically necessary microbiological testing (**CPT code 87635**), which includes CDC testing (**HCPCS U0001**) and non-CDC testing (**HCPCS U0002**) and microbiological testing and non-CDC testing using high throughput technologies (HCPCS U0003 and U0004). **Note:** The AMA CPT Editorial Panel approved the new, specific CPT code 87635.
- BSWHP will cover these costs in full without member cost sharing.
- For members on closed network plans, we will cover these costs fully at in-network providers and with out-of-network providers if a member has trouble accessing such services in-network

### COVID-19 Treatment (Confirmed Positive Diagnosis)

- BSWHP will reimburse providers for treatment according to covered benefits in our plans for those members positively diagnosed with COVID-19.
- BSWHP will confirm a positive diagnosis with the presence of the following diagnosis codes:
  - ICD-10 code B97.29**, used as either a primary diagnosis or a secondary diagnosis appended to a respiratory illness (through 03/31/2020)
  - ICD-10 code U07.1 – COVID-19**, used on or after 04/01/2020 dates of service as designated by CDC.

### COVID-19 Treatment (Initially Suspected, But Without Confirmed Positive Diagnosis)

- BSWHP will reimburse providers for treatment according to covered benefits in our plans for those without a positive diagnosis of COVID-19.
- BSWHP will confirm a non-positive diagnosis with the absence of ICD-10 code B97.29, used as either a primary diagnosis or a secondary diagnosis appended to a respiratory illness.
- BSWHP will affirm a non-positive diagnosis with the absence of **ICD-10 code U07.1 – COVID - 19**, used on or after 04/01/2020
- BSWHP may further confirm a non-positive diagnosis with the presence of ICD-10 code Z03.818, which denotes a ruled-out COVID-19 diagnosis.
- BSWHP may further confirm a non-positive diagnosis with the presence of ICD-10 code Z20.828, which denotes exposure but no confirmed COVID-19 diagnosis.
- For members on closed network plans, we will pay allowed amounts at in-network providers and with out-of-network providers if a member has trouble accessing such services in-network
  - In such a case, we will hold the member harmless from a financial perspective when using an out-of-network provider

### COVID-19 Vaccines and Administration

- At this time, per regulatory guidance, providers will initially not incur a cost for COVID Vaccine product. CMS will update the payment allowance at a later date. Once, updates to payment allowance has been provided by CMS, Plan will update our fee schedule. Providers should NOT bill for COVID Vaccine product if they received it for free
